All exhibits must be in place by 8 p.m., September 25, 2008.
2. Each exhibitor should check in with the Exhibits Chairperson to receive a space assignment.
3. There is no charge for using HGMS cases. The earlier an exhibitor requests an HGMS case, the more likely that they will be able to get one. All cases (new and old) have foam board liners. The measurements of the newer fold-up cases are:
Back36" W, 24" H
Bottom.....35¾" W, 22¼" Depth
Side24" H, 17" top, 22" bottom
4. HGMS cases with cloth linings are assigned on a first-come, first-served basis. Anyone requesting an HGMS case can provide their own linings if they wish, but please let us know well in advance so cases that already have linings can be assigned to someone else.
5. All exhibits must remain in place until the show ends at 5 p.m. on Sunday, September 28, 2008, unless prior arrangements have been made with the Show Chairperson.
6. The Houston Gem & Mineral Society, Inc. will furnish around-the-clock security in the exhibits buildings, but the Society will not be responsible for any loss or damage to the exhibits.
